- All in-boat competitors must be 18 years of age.
- All in-boat competitors must have a full racing APBA membership if a legal resident/citizen of the United States of America; or have an APBA single event membership if not a legal resident/citizen of the USA. Single event memberships will be available at registration.
- All non US legal residents/citizens must have a letter of Authority or card from their respective National Authority.
- Boat drivers from the Unlimited and A Classes must have a certified and/or Appostilled letter from their National Race Boat Federation, indicating that they have the racing experience, capabilities and medical condition to race in these classes. This letter will have to be attached to the entry form and/or shown at the technical inspection.

<u>NOTE</u>: Any boat, both motorized and non-motorized, entering the waters of Idaho is REQUIRED to contribute to the Idaho Invasive Species Fund (IISF). The Idaho Department of Agriculture is responsible for management of the IISF program. The fees generated from the sale of IISF stickers will fund vessel inspections, washing stations and informational materials that will assist Idaho with preventing the introduction of aquatic invasive species. The Western Whitewater Association (Our Safety Boat Group) is a registered vendor and will have stickers available at registration. Stickers are not included in entry fee.

Also the Dept of Agriculture is "hoping" and planning to be present and to inspect boats before they enter any water in Idaho and after they leave the St. Joe River due to some invasive plant species (milfoil) being present in that waterway that we do not want in the Snake, Clearwater or Salmon Rivers. So expect an inspection before and after the St Joe legs of the race for all boats-safety, race and pre-runners.

### **CLASSES**

2012 UIM rules will apply with the following UIM Jet River Racer classes:

- Unlimited—above 7701 cc (jet turbines included in this class)
- A Class—from 5101 to 7700 cc
- CX Class—up to 6424 cc (carbureted engines only, any type)
- FX Class—up to 5740 cc (carbureted engines only, not exceeding 750 CFM)

In order to contend for the UIM titles, awards and trophies, the winner must have completed at least 75% of the race legs. For the overall awards, the winner must have run 100% of the distance and race legs.

#### Unlimited Jet Class SPONSORED BY AMERICAN TURBINE - 300 Series Numbers (U300)

- Hull any shape or material with a minimum length of 16 feet (4.88m)
- Unlimited engine restrictions or modifications, any exhaust c/w mufflers—the use of an efficient muffler is required. The maximum noise level is 120 decibels. It will be compulsory that all boats have one at all times during practice and during the race.
- Mufflers are not required on turbine engines
- Propulsion jet drive
- Roll bar (well braced & mounted)

#### "A" Jet Class SPONSORED BY SHORE LODGE 100 – 200 Series Numbers (A200)

- Hull any shape or material with a minimum length of 16 feet (4.88m)
- Engine displacement—5101 to 7700 cc— shall not exceed 470 cubic inches (7700 cc)
- Superchargers, blowers & turbos are allowed at 1.8 x cubic inch ratio
- Engine shall use gasoline for fuel, any exhaust c/w mufflers—the use of an efficient muffler is required. The maximum noise level is 120 decibels. It will be compulsory that all boats have one at all times during practice and during the race.
- Propulsion jet drive
- Roll bar (well braced & mounted)

## "CX" Jet Class SPONSORED BY <u>OUTLAW EAGLE MFG</u> – 100 or 200 Series Numbers (CX100 or CX200)

- Hull any shape or material with a minimum length of 16 feet (4.88m)
- Stock Crate Engine shall be GM (LS3 Engines 376ci) 515 part#:19171225 or 19244552, or CT525 part#: 19271821 or Ford (392ci) part#: m-6007-d392rt (430/c392rt (475) 374w (540) or Dodge (6.1 hemi) part #P5155067
- Any carburetor, NO fuel injection with gasoline for fuel, normally aspirated only
- Stock crate intake manifold, no port matching on intake or heads, any valve covers
- Any oil pan (no vacuum or dry sumps allowed), any ignition or distributor, any type damper
- No overbore, porting, balancing or engine modifications allowed, factory heads only

#### "CX" CLASS Cont.

- Any exhaust c/w mufflers— the use of an efficient muffler is required. The maximum noise level is 120 decibels. It will be compulsory that all boats have one at all times during practice and during the race.
- Random testing of engines will take place.
- Propulsion jet drive
- Roll bar (well braced & mounted)
- Engine shall use gasoline for fuel

## "FX" Jet Class SPONSORED BY <u>ROGERS TOYOTA SCION</u> – 01 to 99 Series Numbers (FX99)–Crate Motor Class

- Tunnel any shape or material with a minimum length of 16 feet (4.88m) or V bottom/Step tech hull any shape or material with a minimum length of 13 feet (3.96) No Glass Windshields
- Engine GM ZZ4 355 HP CRATE engine—not to exceed 5740 cc (GMPP long block part number 24502609)
- Engine Repairs must meet OEM specifications & weights. No roller rockers allowed, No porting, balancing, port matching or modifications; No overbore allowed; Any type Dampers allowed;
- Any ignition system, any oil pan (no dry or vacuum sumps), any valve covers, Stock GM intake manifold.
- Random testing will take place
- Carburetor 750 CFM maximum.
- Exhaust any exhaust system allowed c/w mufflers--the use of an efficient muffler is required. The maximum noise level is 120 decibels. It will be compulsory that all boats have one at all times during practice and during the race.
- Engine shall use gasoline for fuel
- Propulsion jet drive
- Roll bar (well braced & mounted)

<u>LOCAL CLASSES</u>—Other racing classes can participate, however they will not be recognized with UIM World Title. They will be racing for the American Title only. Local classes are NOT eligible for OVERALL Title.

## "FXV" Class SPONSORED BY <u>COORS-ROCKSTAR</u> – 01 to 99 Series Numbers (FX99)-Crate Motor Class

- V bottom/Step tech hull any shape or material with a minimum length of 13 feet (3.96)
   No Glass Windshields, engines and all specifications same as for FX Class
- No UIM Title, American title only

Registration will take place at the Race Office at St. Maries Lower City Park, St. Maries, Idaho from 10:00 am to 6:00 pm on April 13, 2012.

All Drivers Meetings will be at least 1 hour prior to beginning of each day. Meetings after that will be determined before each leg begins. Non-attendance or tardiness penalties will apply according to UIM rules:

A Driver's Meeting will be held prior to each leg of the race at the indicated time. Where the meeting area is small in its capacity, only the driver and navigator of each race boat entered in the next leg are allowed to attend the Driver's Meeting. A roll call will be held at the beginning of the meeting, the name of each race boat driver will be called out and a 15 minute penalty assessed for drivers being absent when their name is called. If a race boat driver is absent by "Force Majeure" (greater force) the penalty will be reviewed by the Race Committee.

Each team will purchase a minimum of 2 tickets to the Awards Banquet which will be held in Riggins on April 21, 2012; these will be purchased at registration.

#### RULES

- 1. The upper 50% of helmets must be a bright color
- 2. All race numbers must be 24 cm x 4 cm white on black or black on white, or contrasting color with 4 cm border this will be strictly enforced. Each boat must carry a sticker(s) of the title sponsor(s) of the event.
- 3. All Rotating Parts must be guarded if reachable while belted in seats unless boat has a Bulkhead
- 4. Engine Change Rule B. Any team changing an engine during the course of the marathon will be assessed a 15 minute penalty. Any team changing an engine without showing a catastrophic failure and receiving the prior approval of the Race Referee, Race Director or Tech Inspector will be disqualified.
- 5. No black flags should be carried in any of the race boats
- 6. All race boats must have 2 rear view mirrors
- 7. Hand held GPS is allowed with 5.0" screen (diagonally) mounting allowed for purpose of monitoring speed only.
- 8. Media and publicity to be allowed only through and arranged by the Race Committee and its Media/Marketing Director, Kyla Sawyer. All racers participating in filmed interviews will wear the major sponsoring company's hat.
- 9. All boat Drivers must have their National Authority membership and racing license, full APBA membership for US teams and single event APBA membership for foreign teams; and all participating Whitewater Jet Boat Club memberships.
- 10. Fueling on a leg open for racing is NOT permitted. Fueling while the boat is in the water is NOT allowed. Any refueling must be done with the boat on the trailer and at least 33 meters/100 feet away from the waterway. Penalty is leg disqualification up to total DQ.
- 11. World Anti-Doping Alcohol Code in effect suspensions issued after 0.03 blood alcohol level
- 12. Any repairs to CX & FX Class Crate Motors must use parts equivalent to OEM. No overbore's.
- 13. Any racers caught cheating on engines will be disqualified for the entirety of this event. Entry fees and other fees will not be reimbursed or refunded. Other UIM penalties on this issue may be enforced. See section 406.03 in UIM rule book.
- 14. On engine tear downs "All Gaskets at Owners Expense"
- 15. All International teams, including driver, navigator and crew, must produce their National Authority Membership cards and driver must produce racing license.
- 16. The time which will be given to the boats which do not start (DNS) or to the boats which finish after the finish line is closed; or the ones which start and not finish (DNF), will be the time of the slowest boat of their class for that leg which finished within the allowed time, plus the time penalties calculated based on the following ADJUSTMENT FACTORS: DNF = 1.10, DNS = 1.30.

This marathon shall be governed by the 2012 Edition of the Official Rule Book provided by the Union Internationale Motonautique, unless otherwise noted and specifically addressed in this Advanced Program.

#### PROTEST FEES

Any team wishing to lodge an official protest shall do so in a manner provided for in the UIM rules. Each protest shall be accompanied by a protest fee of \$500.00 U.S., said fee being refunded should the protest be decided in favor of the team lodging the protest. Protests will be adjudicated by a committee consisting of 1 representative from each class, including 1 representative from each country attending, and the Race Captain. The UIM Representative will be on the committee, but shall not vote.

#### **PRIZES**

Prize money in each class shall consist of \$10,000.00 per class (Local Class Prize Money yet to be determined), awarded \$50% for 1<sub>st</sub>, 30% for 2<sub>nd</sub>, 20% for 3<sub>rd</sub>. Prizes shall be awarded for 1<sub>st</sub>, 2<sub>nd</sub> and 3<sub>rd</sub> place in each class. Prizes will be awarded for 1st, 2<sub>nd</sub> and 3<sup>rd</sup> place Overall as well.

#### RACE FUEL

Please make your own arrangements for your fuel—DOT regulations limit fuel hauled to 1000 pounds.

The Race Committee WILL NOT be supplying any fuel.

Unleaded Premium Pump Fuel will be available in the towns that are nearby.
